TEMPORARY SIGN GUIDELINES

- 1. Such signs shall not be placed on private property without permission of the property owner on whose property the sign is erected.
- 2. Such signs shall not be placed in or project over public rights of way.
- 3. Such signs may be no larger than six (6) square feet in size and no higher than forty (40) inches from grade.
- 4. Such signs when located in areas other than within residential subdivisions shall be located no less than ten (10) feet from the street pavement and so as not to interfere or obstruct a motorist's view of pedestrian and vehicular traffic.
- 5. Within residential subdivisions, such signs shall be permitted to be located between the street and sidewalk (without written permission) within the public right-of-way so long as they do not interfere of obstruct a motorist's view of pedestrian and vehicular traffic.
- 6. Such signs shall not be placed so at to interfere with the corner vision clearance at intersections.
- 7. No such signs shall be attached to any existing utility structure, tree, fence, or any existing public or private sign or sign structure.
- 8. Signs which by color, location, or design resemble or conflict with traffic control signs or signals, or obstruct the view of an intersection, or a street or highway with a railroad crossing are prohibited.
- 9. If placing such signs in a residential subdivision, please be sure that doing so does not violate that subdivision's restrictive covenants.
- 10. After the event/game/contest/etc. has occurred, such signs should be promptly removed.
