TOWN OF FERDINAND REGULAR MEETING

June 18, 2024

The Ferdinand Town Council met for a Regular Meeting at 6:30 PM on Tuesday, June 18, 2024, in the Ferdinand Town Hall. Present were Council President, Ken Sicard; Vice-President, Debbie Johnson; Council Member, Ron Weyer; Attorney, Sharon Bohnenkemper, and Clerk-Treasurer, Tamara Miller. Also in attendance was Lauren Mundy, representing the Ferdinand Main Street group.

Debbie moved to approve the Minutes of the May 21, 2024, Council Meeting and the April 24, 2024, Special Meeting. Sicard seconded. Weyer abstained. Motion carried 2-0.

Police Chief Blessinger stated the department is accepting Police Officer applications until June 24, 2024. She thanked Jane Potter and the Patoka Quilt Guild for the blankets donated to the department. She reminded residents to mow their yards and please do not blow grass clippings into the street. Blessinger requested permission for Officer Randle to attend the Caliber Public Safety Conference in Plainfield on July 30 and 31, 2024, with transportation, two nights in a hotel, and meals. Ron moved to approve the request. Debbie seconded. Motion carried 3-0. Blessinger stated the Heimatfest safety plan has been approved and distributed and requested the Council approve the Heimatfest 5K Route as submitted. Sicard moved to approve the 5K Route. Debbie seconded. Motion carried 3-0.

Todd Fischer, Electric Superintendent, requested approval to purchase wooden poles for the electric department for \$16,645.90 Debbie moved to approve the request. Ron seconded the motion. Motion carried 3-0.

Ben Brinkman, Water/Wastewater Superintendent, requested permission to send Kyle Lechner, Clint Meyer, Brian Hoffman and Austin Ryan to the Indiana AWWA Southern Symposium, in Huntingburg on June 27, 2024, the total cost is \$320 plus transportation, lunch is included. Ron moved to approve the request. Debbie seconded. Motion carried 3-0. Brinkman requested permission for Kyle Lechner, Hoffman, Meyer, Ryan and Brinkman to attend the IFA Southwest Regional Meeting (2 hours) at an Evansville Wastewater Facility. Ron moved to approve the request. Debbie seconded. Motion carried 3-0. Brinkman has been asked to be on the Board for

the Southwest Region. Sicard stated it is Brinkman's decision to be on that Board.

Brinkman requested permission to solicit three bids for the water main materials for Royal Ridge. Debbie moved to approve the request. Ron seconded. Motion carried 3-0.

The Council thanked Universal Design Associates for their \$13,150 donation of professional services related to the 5th Street Park Master Plan.

Sicard, Town Council President, appointed the Town Council: Ken Sicard, Debbie Johnson, and Ron Weyer to the Ferdinand Redevelopment Commission. The Town Council, voted to appoint Dan Collignon, Tamara Miller, and Nathan Schuler, (non-voting member) from the School Board, to the Ferdinand Redevelopment Commission. Motion by Debbie. Ron seconded. Motion carried 3-0.

Ron moved to approve the Universal Design Associates' Proposal for CCMG 2024-02, \$28,000 Grant Planning and Application Phase Fee, and \$12,000 Final Design/Engineering & Bidding Phase Fee for a total of \$40,000. Debbie seconded. Motion carried 3-0.

Miller distributed the accounts receivable report to keep the Council informed.

Brinkman stated that the water customer survey with WTH is progressing.

Debbie reported the IEDC is still reviewing the projects that were submitted for the 2.0 READI Grant.

Johnson stated the comprehensive plan proposals will be presented at the joint public meeting of the Plan Commission, Town Council and steering committee on June 19, 2024 at 6 PM at Town Hall.

EV Charger Hold Harmless Agreement has not been returned.

Bohnenkemper reported the DCLA will meet on the last Wednesday in June.

Debbie moved to approve Sicard's request for a one-night hotel stay for the AIM Board of Directors meeting on July 10-11, 2024 at French Lick. Ron seconded. Motion carried 3-0.

Miller requested the Council allow Sicard to sign the CCMG 2024-02 Town's Commitment Letter for up to \$300,000. Debbie moved to approve the request. Ron seconded. Motion carried 3-0.

Ron moved to approve Miller's request to declare the 2018 Taurus as a surplus asset. Debbie seconded. Motion carried 3-0. The Taurus will be advertised for sale and the sealed bids will be accepted until the close of business July 15, 2024 and opened on July 16, 2024 at 7 PM.

At 7 PM, Ron moved to close the acceptance of bids for the CCMG 2024-01 Road Projects. Debbie seconded. Motion carried 3-0. The following bids were received:

Brett Schipp with Universal Design Associates and Bohnenkemper (as proxy for Tom Lueken) left the meeting to review the bids.

Mark Durcholz addressed the Council. He stated his daughter had a close call near the Ferdinand Elementary School when crossing the street while walking to school. Durcholz asked if there is an option for a button-activated crosswalk. Chief Blessinger will explore signage options with Lueken, Johnson and the school principal. The appropriate crossing signs will be ordered.

Schipp and Bohnenkemper returned to the meeting. Bohnenkemper advised the low bid was within the budget estimates and recommended the Council accept the low bid from C & R Construction for \$236,240.00 with a unit price of \$150 per cubic yard, with a start time of March 1, 2025 and a stop time of July 1, 2025. Ron moved to approve the recommendation. Debbie seconded. Motion carried 3-0.

Debbie moved to approve a special claim from Calcar Paving for the CCMG 2023-02 road paving for \$458,159.96. Ron seconded. Motion carried 3-0. Ron moved to pay regular claims. Debbie seconded. Motioned carried 3-0.

The Ferdinand Police Department members completed the Standard Field Sobriety Training on 05-03-24 at the Ferdinand Police Department. Not only is this refresher required on a bi-yearly basis, but also required for officers to participate in grant funded activities.

On 05-14-24, I attended the IPEP webinar held at Ferdinand Town Hall. This training assists with work related incidents and prevention.

On 05-20-24 the Ferdinand Police Department hosted training on vehicle QCB taught by LawMan Tactical Trainers. Vehicle CQB is an accelerated shooting class focused on positional shooting and critical light manipulations in and around vehicles. Students were taught to push boundaries of "traditional" cover and concealment utilizing various cars and trucks in true 3D environment. Drills will incorporate critical weapon employment while engaging threats in, around, from, over and under vehicles with a heavy emphasis on problem solving. Live ballistic demos with a variety of ammunition were conducted as the class explored ballistic deflection, deformation, penetration and terminal effect in direct correlation to various vehicle mediums.

Several area departments attended the training as well as agencies from Indianapolis. This allowed agencies who work closely with one another to train together to gain the newest training methods for keeping officers safe. We plan on hosting additional classes in the fall.

On 05-29-24, I was invited to the Indiana Law Enforcement Academy to teach the current ILEA class. I teach Sudden Unexpected Death in Infants and Elderly Abuse to the recruits.

FPD is currently exploring radio purchasing options. Ferdinand Police Department has historically struggled with reception in this area. We are currently using 4 radio demos to see what would best fit our needs and be the best investment for the town.
