TOWN OF FERDINAND REGULAR MEETING June 17, 2025

The Ferdinand Town Council met for a Regular Meeting at 6:30 PM on Tuesday, June 17, 2025, in the Ferdinand Town Hall. Present were Council President, Ken Sicard; Vice-President, Debbie Johnson; Council Member, Ron Weyer; Attorney, Sharon Bohnenkemper, and Clerk-Treasurer, Tamara Miller.

Sicard stated, this meeting is being recorded. This is a reminder this meeting is being live streamed and recorded. Your attendance at this meeting is your consent to be live streamed, recorded and rebroadcast on the Town's website. If you have any electronic devices, please put them on airplane mode. Thank you for your cooperation.

Ron moved to approve the Minutes of the May 20, 2025, Town Council Meeting. Debbie seconded. Motion carried 3-0.

Rob Randle, Police Chief, reported that Glenn and Poole graduated from the Police Academy on May 23, 2025.

Debbie moved to approve John Hoppenjans, Fire Chief, hiring Patrick Recker as a volunteer firefighter with a start date of July 1, 2025, pending drug screening. Ron seconded. Motion carried 3-0.

Ben Brinkman, Water and Wastewater Superintendent, stated Steve Lechner has retired from his part-time position. Ron moved to approve Brinkman's request to purchase a new locator for \$10,002.23 split between the water and wastewater departments. Debbie seconded. Motion carried 3-0.

Matt Weyer, Park Board President, welcomed Andy Berg to the Park Board and thanked Natalie Howard for her years of service on the Board. Tom has been given permission to interview applicants for the seasonal park position.

Sicard stated the Redevelopment Commission met earlier this evening and is still waiting to hear regarding the READI 2.0 grant.

Debbie moved to approve the Heimatfest 5K route presented by Karl Hinson and accepted by Chief Randle. Ron seconded. Motion carried 3-0.

Evan Daunhauer requested that the water line on Lot 102 Krampe's Second Addition on 20th Street be moved due to a pool installation on his property. The Daunhauers will reimburse the Town for the materials and the Town's water department will provide the labor to relocate the water main. Brinkman stated the work will be done sometime after July 14th. Bohnenkemper will prepare the necessary agreements regarding the water main relocation and the public utility easement. Debbie moved to approve. Ron seconded. Motion carried 3-0.

Ron moved to adopt Ordinance 2025-07, An Ordinance Amending the Ferdinand Municipal Code Chapter 1.10 Entitled Policy and Procedure for Use of the Ferdinand Senior Citizens Center, at the meeting it was introduced. The name of the rental venue is hereby changed to Station 313. Debbie seconded. Motion carried 3-0.

At 7:00 PM, Ron moved to open the sewer rate hearing. Debbie seconded. Motion carried 3-0. Miller stated that the last sewer rate increase was over nine years ago. Miller stated that LWG CPA's and Advisors prepared a sewer rate study based on 2024 actual data and 2025 budgeted data. Midwest Engineers prepared a Preliminary Engineering Report detailing the probable project costs that need to be completed for the wastewater system. Based on this information, the increase is necessary to continue to operate the plant in a safe and efficient manner. The first rate increase (20%) would be effective July 10, 2025 and the second increase (10%) would be effective June 10, 2026. On July 10, 2025 - A customer using 3000 gallons of water (average residential user), the old rate would have been \$56.44, the new rate is \$67.73, an increase of \$11.29 per month. This is \$2.26 a day for the wastewater service. On June 10, 2026 – A customer using 3000 gallons of water would pay \$74.49, an increase of \$6.76 per month. This is \$2.48 per day for wastewater service. The increased revenue will allow the sewer department to secure debt to finance the most important projects and maintain the vital operations of the wastewater plant. There were no questions from those in attendance. Ron moved to close the public hearing. Debbie seconded. Motion carried 3-0. Ron moved to adopt Ordinance 2025-06, an Ordinance Amending Section 10.08.030 of the Ferdinand Municipal Code Regarding Sanitary Sewer Service User Rates and Charges. Debbie seconded. Motion carried 3-0.

CCMG 2024-02 - Knies Construction is working on the 15th Street project and the 18th Street Park cul-de-sac. Tom Lueken will meet with Mr. Fritz, the owner of the building serviced by the sprinkler pit that was discovered under 15th Street. Knies is working on the 18th Street project while the delay on a portion of 15th street is being resolved.

There is no CCMG 2025-02 call at this time. Tom is working with Universal Design on a future CCMG call. Debbie requested the list of potential CCMG projects from Tom.

Miller distributed the accounts receivable report to keep the Council informed.

Brinkman stated that Kyle Lechner is working on the remaining 42 water surveys.

Sicard stated that we are waiting for Eck Mundy to prepare a proposal for a cyber security plan.

Debbie stated there is no news regarding the READI 2.0 grant.

Debbie stated that today, the Comprehensive Plan Steering Committee received the Comprehensive Plan that will be proposed to the Plan Commission. The Plan Commission will make a recommendation to the Town Council on whether to adopt the plan. There is a printed copy available to review at the library and Town Hall. There are links to the plan on the website and on Facebook to view the 130-page document if the public would like to review and make comments.

Debbie stated she spoke to Brett Schipp with UDA regarding the sidewalk/trail from the High School property to the Old Town Lake. UDA is waiting on survey information to make any recommendations to the Town.

Sicard stated that he met with Indiana Senator Daryl Schmitt and received the latest property tax projections. He will review the projections and share the information.

Tom stated he has not yet scheduled interviews with applicants for the seasonal park position.

Miller stated that the deadline to start livestreaming public meetings is July 1, 2025. Tonight is a test night. The Town will be ready by July 1.

Debbie moved to approve Sicard and Miller to sign off on the Contract for Services with Indiana 15 Regional Planning Commission for planning, technical, and administrative services support in connection with the SS4A project for a fee of \$5,000 as recommended by Bohnenkemper. Ron seconded. Motion carried 3-0.

Ron moved to approve Sicard to attend the AIM Board of Directors meeting in Mishawaka on June 23-24, 2025, with hotel and mileage. Debbie seconded. Motion carried 3-0.

Ken moved to reschedule the October 21st Town Council Meeting to October 28th due to a conflict with an AIM Idea Conference. Ron seconded. Motion carried 3-0.

Debbie stated that the health insurance committee will meet tomorrow for the first time this year and then meet monthly.

Bohnenkemper was instructed by Council to send the Pole Agreement with the proposed changes to Dubois REC.

Bohnenkemper sent a letter to Allen Durcholz, as requested, regarding the 1305 Main Street property and the 825 and South Club Road. After receiving the letter, Durcholz did request and receive a building permit for the 825 and South Club Road property. Durcholz responded he has mowed the Main Street and West 13th Street properties. He also stated his plans to complete repairs on the in-Town properties. The item will remain on the agenda for follow-up.

Sicard will complete the Flood Plain Administrator certification by the end of June. Debbie moved to appoint Ken Sicard as the Flood Plain Administrator for the Town of Ferdinand. Ron seconded. Motion carried 3-0.

Ron moved to pay regular claims. Debbie seconded. Motioned carried 3-0.
